

Service Terms & Conditions of Agreement

By using Valencia Estimates LLC., you agree to comply with all of the Contract Terms of Agreement set forth herein:

1. **SERVICE HOURS:** In the performance of the estimating services, the hours of operation of Valencia Estimates LLC., on any given day, are entirely within the Valencia Estimates LLC.'s control; furthermore, you will rely upon Valencia Estimates LLC. to put in such number of hours as may be reasonably necessary to fulfill this agreement, without additional and unforeseen consultation & change order charges & modifications, prior to servicing. Completion time based on regular business days - Monday to Friday (excluding all holidays).
2. **COMPENSATION:** You will be responsible for full payment to Valencia Estimates LLC. for the estimated fee, sum agreed to, prior to completion of takeoff. Valencia Estimates LLC. and client will agree to a new sum to be added on for any additional project related work, as necessary, for additional estimating, editing of layout, editing of material takeoff, and/or corrections per addendums or special requests. All compensation is non refundable.
3. **INVOICING & PAYMENT:** Valencia Estimates LLC. will be requesting full payment for the entire amount, before or upon completion of project, as stated above; Payment can be made by credit/debit card (via Paypal merchant services) - a invoice will be provided by Valencia Estimates LLC. If client cannot use paypal, payment can also be sent via Zelle to Business Account
4. **MODIFICATIONS & ALTERATIONS:** Valencia Estimates LLC. upon request, by written authorization, will modify, edit, alter estimates, per necessary change order requirements, if Valencia Estimates LLC. was the original estimator of the project. ALL CHANGES, MODIFICATIONS AND ALTERATIONS are payable bto sum agreed to prior to beginning additional work. Any change orders for changes or extra work shall be incorporated in, and become part of this Estimate Quote.
5. **EXCLUSIONS:** NO amounts will be provided for adhesives, floor prep & self-levelers, tile grout, thin-sets & mortars, laths, moisture testers,vapor barrier materials, cleaning & polishing materials. Additionally, demo of existing flooring areas are not included on takeoff amounts. Valencia Esimtates LLC. and client shall agree on final materials to be included in takeoff prior to comencement of work.
6. **INDEPENDENT CONTRACTOR:** Valencia Estimates LLC. will furnish services as an independent contractor and not as an employee of your company, nor affiliated with your company. Valencia Estimates LLC. has no authority to act for, represent, or bind you or any other company affiliated with you in any manner.
7. **NON DISCLOSURE:** Customer agrees to keep confidential all Valencia Estimates LLC. materials, including but not limited to, this Agreement, discounts, promotions, rates, charges, reports, references, invoices & estimates, and not to reproduce or release to any third party or to any of Valencia Estimates LLC.'s competitors.
8. **WARRANTIES & LIABILITIES:** Valencia Estimates LLC. makes no representation or warranties with respect to any information, materials, graphics found on our website/ and or services. Under no circumstances shall Valencia Estimates LLC. be held liable for any damages (including, but not limited to loss of use or lost profits), arising out of or in any manner connected with the use of information or services, or the failure to provide information or services, from us.
9. **IN THE EVENT OF NON-PAYMENT** of the entire amount due for services rendered, Valencia Estimates LLC.. shall be entitled to recover from Customer all reasonable attorney's fees and cost of collection and suit incurred expenses.
